APPOINTMENT AND POSTINGS.

Date of appointment – 9-3-1973 Under Home Department.

Posted as P.A. to the then Police Commissioner.

Transferred and posted in 1974 as P.A. to the then Hon'ble Chief Justice, High Court of Sikkim. Justice S.K. Prasad.

Sikkim was merged into the Union of India on 16th May, 1975.

Mr. Justice Rajender Sachar, Judge of Delhi High Court was appointed as Chief Justice of Sikkim High Court. From June, 1976 worked as Private Secretary to the Chief Justice on officiating appointment. District and sessions Courts and Civil Judges Courts had to be set up in accordance with the provision of Indian

Constitution but High Court had only one officer and as such I got opportunity to learn courts' rules on various subject matters. In 1978 separate Service Rules was framed for High Court employees and as such I took transfer to Government Department in 1979 as O.S. in the L.S.G. Deptt. and then got posting and appointment as Private Secretary to the then PWD and Power Minister.

In August, 1984, transferred from Home Department to Finance Department and worked as Under Secretary till 29th August, 1989. During this period, works of Planning and Development also was assigned from time to time in addition to the works of Under Secretary, Finance Department.

In August, 1989 Promoted and posted as Deputy Secretary, Land Revenue Department and worked till December, 1989.

In January, 1990 transferred and posted as Deputy Secretary-1, Home Department and worked till November, 1991.

In November, 1991 Transferred from Home Department and posted as Additional District Magistrate-cum-Collector, South District from November, 1991 to September, 1993. During this period SDF party led by Mr. PAWAN Kr. CHAMLING was formed in Namchi. Sangram party led by Mr. N.B. Bhandari who was in power organized youth camp at Namchi with about 300 vehicles. D.C. had come to Gangtok to apprise the Government regarding the situation of law and order problems cropped up with the rally and youth camp of Sangram party. All of sudden procession and rally was started from both the parties which had become like a wild fire but I am proud to say that the situation was controlled without loss of life and property except damage of tents put in the youth camps at Namchi Ahaley ground. Whereas at Gangtok the procession was only from SDF party but many vehicles were burnt and many people suffered injuries, the details are available in the records of relevant time. Power of Magistrate was to be exercised as per old Cr.P.C. 1889.

In September 1993, transferred from the post of Additional District Magistrate-cum-Collector, South District and posted as Deputy Secretary, Education Department and worked till December, 1993. Even after my transfer from the South district, I was appointed as Special Magistrate for Rongpo and Singtam area by Home Department for law and order duty under old Cr.P.C. 1889 in addition to Office Works of Project Officer, Welfare Department till Assembly constituency election of 1994.

In January, 1994 transferred from Education Department to Welfare Department as Project Officer and worked till 29-5-1996.

In June, 1996, transferred from Welfare Department to Education Department as Deputy Secretary Legal Cell and Text Books Section of Education Department. Taken over charge of 23 (twenty three) pending cases of High court and Supreme Court in addition to works of administration of Text Books section and worked till December, 1997.

In December, 1997, transferred from Education department to SRDA under Rural Development Department as Project Director and worked till November, 1999.

In December, 1999, transferred from SRDA, RDD to Animal Husbandry Department, as Joint Secretary and worked till March, 2000.

In March, 2000, transferred from the Animal Husbandry Department to Land Revenue Department, as District Magistrate-cum-Collector, West District and worked till June, 2003. Conducted elections as District Election Officer and Returning Officer.

In June, 2003, transferred from District Collector, West to Joint Secretary, Head Office, as Joint Secretary and promoted as Additional Secretary in the Land Revenue and Disaster Management Department and worked till April, 2005.

In May, 2005, transferred and posted as Director, Commerce and Industries Department, Government of Sikkim.
